

## PRODUCT SPECIFIC CONTRACTUAL TERMS AND CONDITIONS FOR BASE OIL AND WAX PRODUCTS

### IN GENERAL

The Product Specific Contractual Terms and Conditions (PSCT) is valid for all MOL Base oil and waxes products) to be sold outside Hungary.

The current PSCT is applicable together with the valid GT&C.

The GT&C and PSCT shall form integral part of the Contract.

The present GT&C and PSCT are available on MOL's website (<https://molgroup.info/en/products-and-services/general-terms-and-conditions>) in printable version.

### ORDERING PROCESS

1. Buyer shall send its monthly expected demand (in weekly and product breakdown) to Seller via e-mail ( [baseoil@mol.hu](mailto:baseoil@mol.hu); [paraffin@mol.hu](mailto:paraffin@mol.hu) ), not later than 9:00 am every month on the 23<sup>rd</sup> (or the last working day before the 23<sup>rd</sup>) previous to the subject month. Buyer acknowledges that despite not sent monthly expected demand, it is entitled to place order during the subject month, but in this case its order will be considered as additional spot demand therefore prioritized lower as those ones which were sent until the 23<sup>rd</sup>.
2. Buyer shall place the order in written form (via e-mail) preferably using Buyer's "Order form" filling in all the requested information, not later than
  - a. In case of Base Oil and Liquid Wax every Wednesdays until 9.00 am, on the week prior to the requested delivery week.
  - b. In case of Solid Wax (Slabs, Pastilles) anytime, taking into consideration 1-week minimum lead time between submitting the order and ETD.
3. The orders shall contain the following information: name and code number – if any - of the Product, quality, quantity, destination of the Product, consignee of the delivery, required ETA/ETD, delivery instruction.

Additionally

- a. in case of road delivery in Buyer's road truck: name of the carrier and identification number of the vehicle;
  - b. in case of rail delivery in Buyers RTCs: name of the carrier and the list of RTC IDs;
  - c. in case of barge delivery in Buyer's barge: name of the barge.
4. Seller shall send a dispatch advice containing the date of dispatch, the weight of the goods delivered and the identification/plate number or name of the vehicle, latest on the next working day after dispatch of the Product.

### REGULATIONS

**Additional regulations in case of consignee is in the territory of Italy, or delivery is arranged by Buyer and delivery route goes through the territory of Italy (Transit).**

**Duty of notification in the Italian Traceability System of Lubricants transported on road (hereinafter abbreviated as: CAR)**

If the goods are transported by road and will be released in Italy or the goods will be transported through Italy, Buyer acknowledge that transport can only be started in possession of a CAR number due to the obligations set out in the Italian Minister Decree 22/04/2020 (Traceability of lubricants)..

Therefore, if Buyer is obliged to create CAR request in CAR system, Buyer shall notify Seller via email accordingly at latest 3 working days before requested arrival date of delivery or to provide Seller in time with the data necessary for the CAR request.

In the event of a change regarding the originally given data falling in the sphere of the Buyer, the Buyer shall immediately provide Seller with the changes specifying the exceptional and justifiable reasons supporting the change request, pursuant to art.6 D.Lgs. 22/04/2020.

Buyer undertakes to pay the charges stated by the Italian tax authority (penalty or other costs) on non-compliance of CAR data supply due to the failure of Buyer or the contractual transporter of Buyer, should such charges be paid by Seller to the tax authority. These charges must be paid by Buyer against debit note issued by Seller within 15 days from its receipt.
